



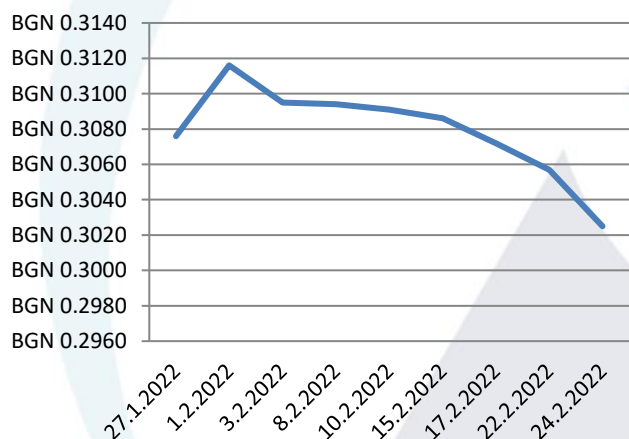

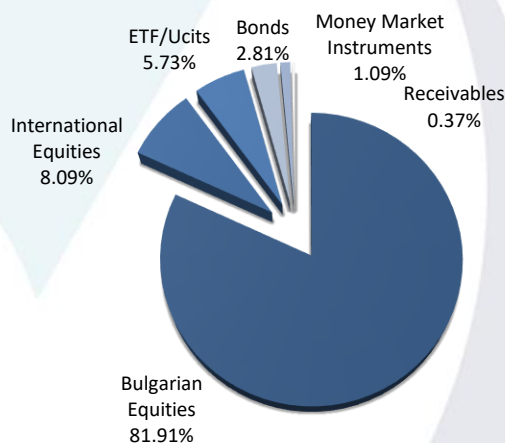

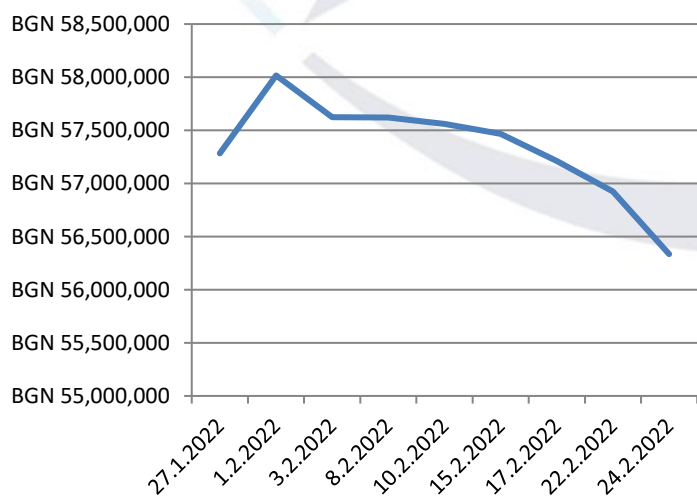
NAV per unit for February
