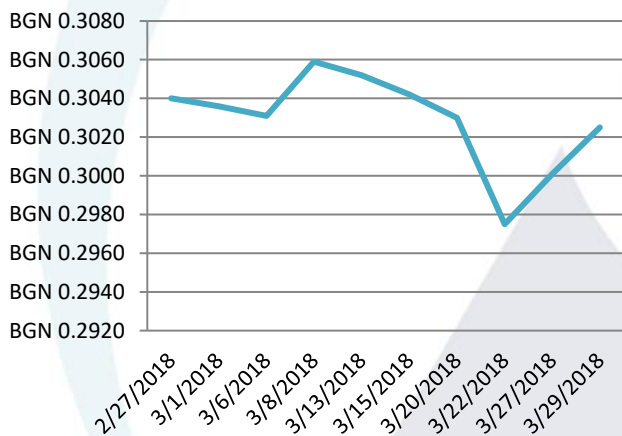

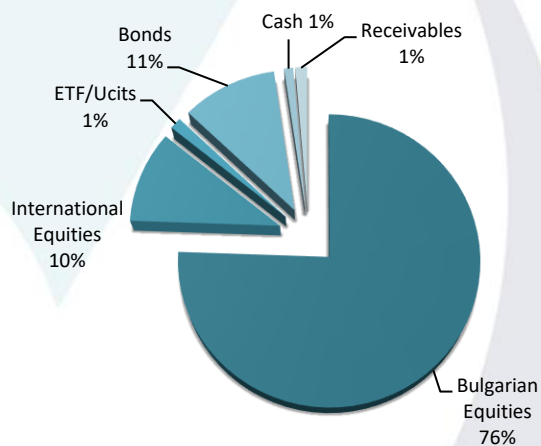

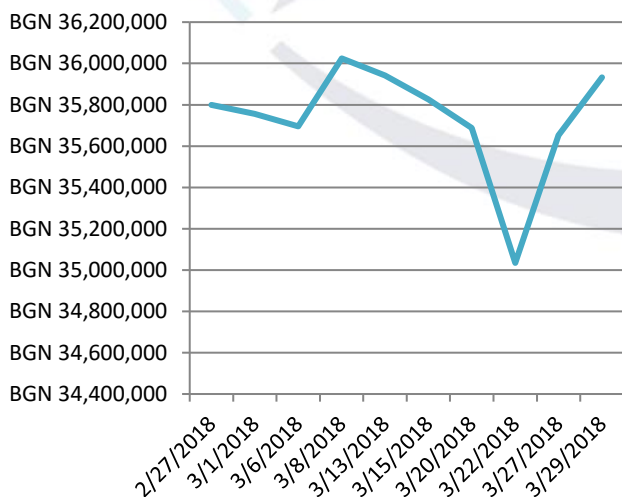
**NAV per unit for March**
