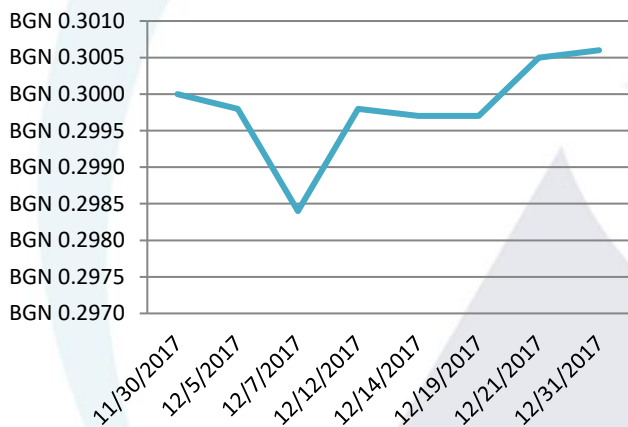

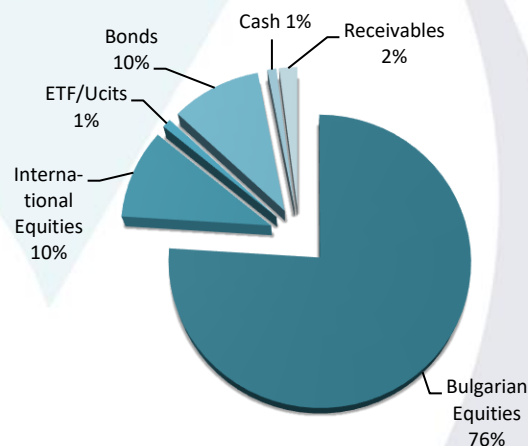

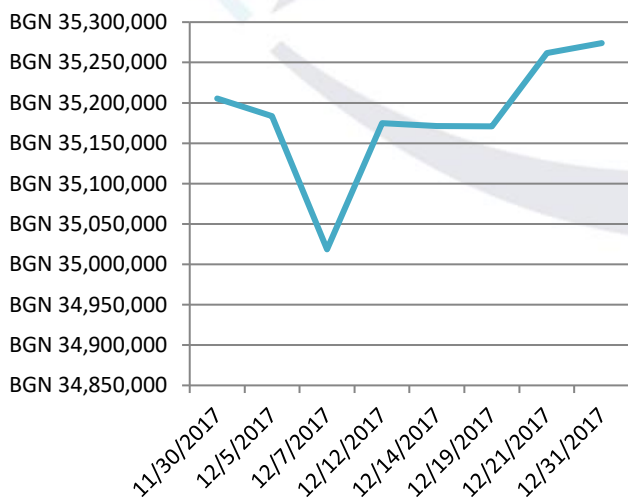
NAV per unit for December
