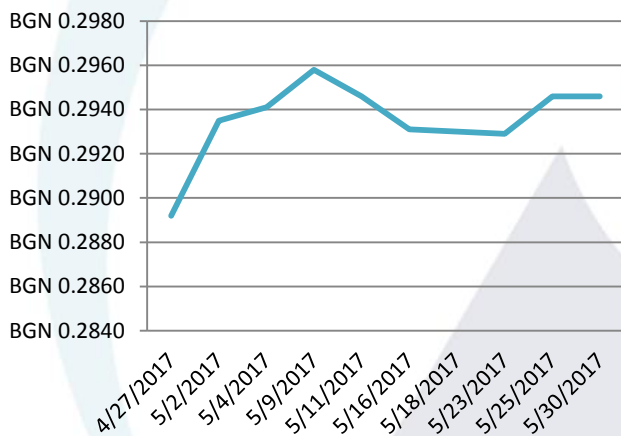

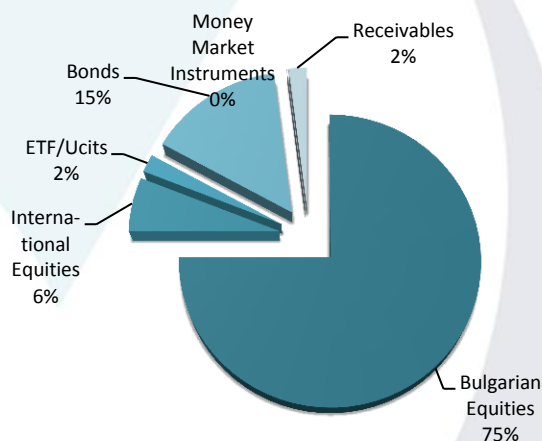

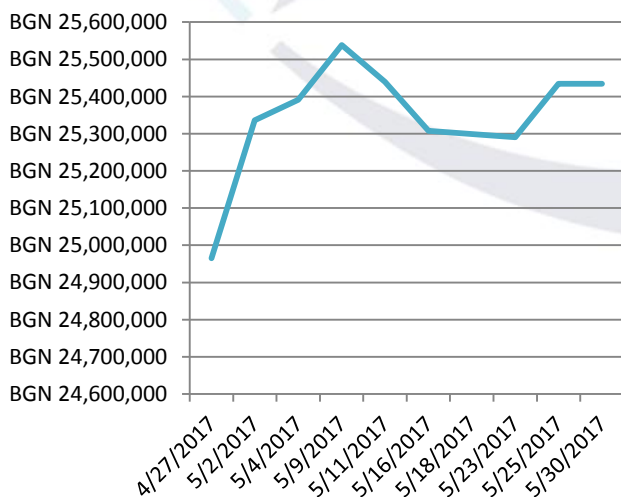
NAV per unit for May
