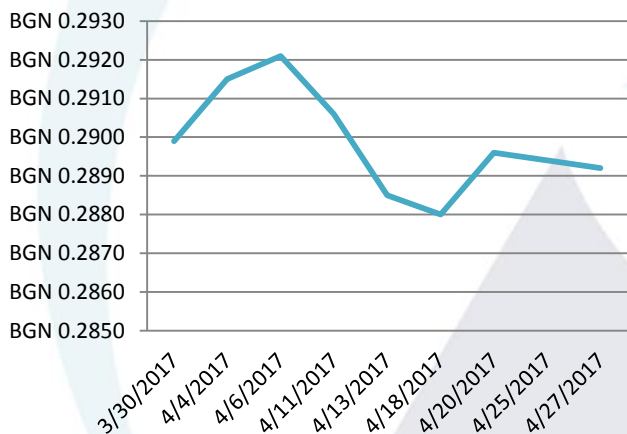

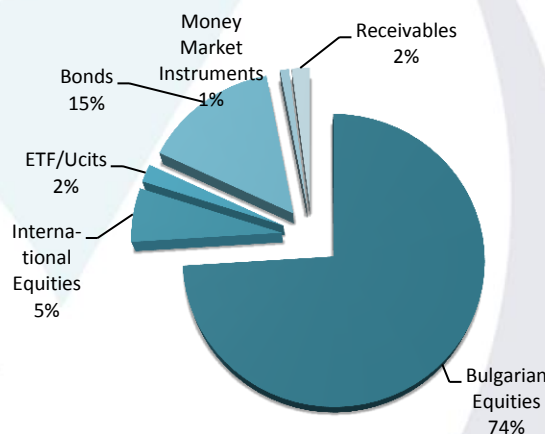

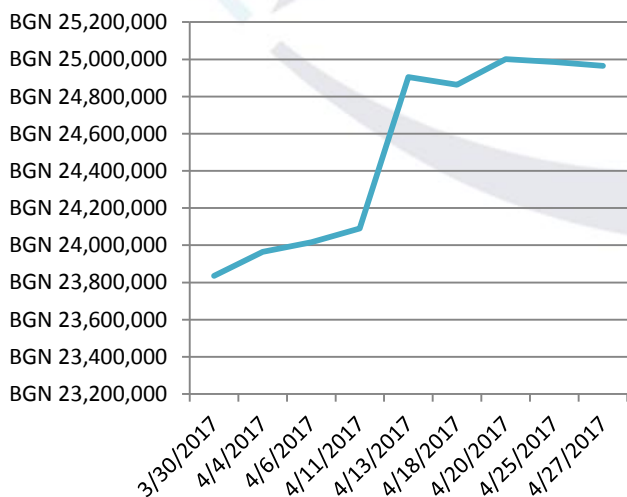
NAV per unit for April
